Application temperature	Can be applied to steel as low as - 5 c. The steel must be at least 3 degrees above the current dew point. (see Dew point calculator on website site)
Application	Rustbuster Pro-Wax Injection kit, Lemmer HD460 Pro-Rust proofing kit, Elite Rustproofing Injection Kit.
	It is not recommended to thin Corrolan Active
Heating and Thinning	Heating : Warm Corrolan Active to 20-40°C to reduce viscosity and facilitate spraying. During colder months, heating to 30-40°C may be necessary.
Cleaning	Clean up using Corrolan Turbo.
Safety	Although Corrolan is a non-hazardous product PPE is recommended. Goggles, spray mask, spray suit and gloves. If you are allergic to Lanolin, do not use Corrolan products.
Storage	Store at 20°C or higher for optimal consistency.
	Colder or warmer storage will not damage the product but will affect viscosity.
	Keep containers sealed when not in use to prevent contamination.
